WITH YOUR MONTHLY PAYMENTS DEDUCTED AUTOMATICALLY, YOU'LL SAVE TIME AND MONEY!

❖ What do I need to know about Automatic Direct Payment?

When you enroll in the automatic payment option, you authorize Mortgage Servicing Solutions (MSS) to deduct the full amount of your monthly payment from a designated bank account monthly.

How is my mortgage payment processed?

On the date you selected, either 1st or 5th of each month, MSS's bank will instruct your bank to deduct the amount due from your checking or savings account. Your bank then withdraws that amount and forwards it electronically to MSS.

Is there a charge for this service?

No. Unlike some other institutions that charge per transaction, MSS does not charge any fee for this service.

❖ How can I be sure a payment was deducted from my account?

The payment will be shown on your monthly statement from your bank. The statement will indicate the payment date and amount clearly itemized.

❖ Why do I need to enclose a voided check or deposit slip in my application?

A voided check or deposit slip contains the banking information that MSS needs to set a borrower up on automatic direct payments.

❖ I sent in my application. When will my payments be withdrawn?

MSS will notify you in writing of the date for the first payment deduction from your bank account. Until notification, please continue to remit your payment.

Can I pay additional principal to my loan?

You can authorize MSS to deduct any amount in addition to your monthly payment to be applied to your principal balance. Over time, this will lessen the term of your mortgage.

Any changes to this agreement must be made in writing to Mortgage Servicing Solutions 15 days prior to the next effective date. Multiple returned or rejected payments will result in the cancellation of the option.
